

## Camsat Privacy Policy

Camsat respects the users' right to privacy. We pay special attention to the protection of your personal data and we use appropriate technological and legal solutions to prevent interference with your privacy as our client. We strive to ensure that each of our clients using the services and visiting our websites and entrusting us with their personal data in any other way feels completely safe. We exercise the utmost diligence in connection with the processing of personal data, in particular in the field of preventing unauthorized access to them, the possibility of their loss or unlawful dissemination. We store personal data carriers in closed apartments and in closed closets.

Please read our privacy policy, in accordance with Art. 13 sec. 1 and sec. 2 of Regulation 2016/679 of the European Parliament and of the Council (EU) of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/WE (GDPR).

### § 1. General provisions

1. The data administrator is **Camsat** based in Solec Kujawski, ul. Ogrodowa 2a, entered into the Register of Entrepreneurs under the NIP number: 953-193-77-38 REGON: 093144784. Data protection is carried out in accordance with the requirements of generally applicable law, and their storage takes place on secured servers.
2. For the interpretation of terms, a glossary of the Regulations is used or as described in the Privacy Policy (if it results directly from the description).
3. For the purposes of better reception of the Privacy Policy, the term "User" has been replaced with the term "you", and the term "Administrator" with the term "we". The term "GDPR" means Regulation 2016/679 of the European Parliament and of the Council (EU) of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/WE.
4. We respect the right to privacy and we care about data security. For this purpose, it is used, among others secure communication encryption protocol (SSL).
5. Personal data provided in the forms on the website [www.camsat-cctv.com](http://www.camsat-cctv.com) are treated as confidential and are not visible to unauthorized persons.

### § 2. Data administrator

1. The service provider is the administrator of his clients' data. This means that if you have an account on our website, or if you send a form with an inquiry from the website, and send us an e-mail directly, we process your data such as: name, surname, e-mail address, telephone number, position, workplace, IP address. That is ordinary data, the regulations related to ordinary data are covered by Article 6 of the GDPR (Lawfulness of processing).
2. The processing of your personal data will take place on the basis of art. 6 GDPR and for marketing purposes, the Administrator refers to a legitimate interest, which is collecting statistical data and analyzing traffic on the website.
3. Your personal data will be stored for the period from 1 day to:
  - a. 6 months in the case of data received for recruitment purposes;
  - b. 5 years in the case of receiving data for the purpose of implementing the Purchase / Sale Agreement between you and us, counting from the date of the last Commercial Invoice issued by us to you;
  - c. until you withdraw your consent given to us for marketing contact;
  - d. until the expiry of the usefulness and / or until the marketing opportunities are used and the data needed to conduct business activity is used.
4. The service provider is also the administrator of people subscribed to the newsletter.

5. Personal data is processed:
  - a. in accordance with the provisions on the protection of personal data;
  - b. in accordance with the implemented Privacy Policy;
  - c. to the extent and for the purpose necessary to establish, shape the content of the Agreement, amend or terminate it, and correctly implement the Services provided electronically;
  - d. to the extent and for the purpose necessary to fulfill legitimate interests (legitimate purposes), and the processing does not violate the rights and freedoms of the data subject:
    - to the extent and purpose consistent with the consent expressed by you, if [for example] you subscribed to the newsletter,
    - to the extent and purpose consistent with your consent, if [for example] you signed up for the webinar.
6. You have the right to access your personal data, the right to rectify it, delete it, as well as the right to limit its processing, the right to withdraw consent, the right to transfer data, the right to object to the processing of your personal data. You have the right to lodge a complaint with the supervisory authority if, in your opinion, the processing of your personal data violates the provisions of the EU GDPR Regulation.

8. We reserve the right to process your data after termination of the Agreement or withdrawal of consent only to the extent to pursue possible claims in court or if national or EU regulations or international law oblige us to retain data.
9. The Service Provider has the right to share the User's personal data and other data with entities authorized under the applicable law (e.g. law enforcement authorities).
10. The deletion of personal data may occur as a result of the withdrawal of consent or filing a legally admissible objection to the processing of personal data.
11. The service provider does not share personal data with entities other than those authorized under the applicable law.
12. Personal data is processed only by persons authorized by us or by processors with whom we closely cooperate.

### **§ 3. Google Analytics tools**

1. Camsat websites use Google Analytics tools. More information on the use of Google Analytics tools by Camsat is available on this website: <https://marketingplatform.google.com/about/analytics/?hl=en>
2. In order to give users visiting our websites more choices about how their data collected through Google Analytics tools is used, Google has developed [a browser add-on to block Google Analytics](#). The add-on communicates with the Google Analytics JavaScript protocol (ga.js) to convey information that data about website visits should not be sent to Google Analytics. The browser add-on to block Google Analytics does not block data transmission to the website itself or other web analytics services.

### **§ 4. Navigation markers**

1. A beacon is a small picture file placed on a website that allows the collection of specific information sent by the user's computer, such as IP address, time of page visit, browser type, cookies installed on previous visits by the same server. The use of navigation markers by Camsat is in accordance with applicable law.
2. Camsat or service providers may use navigation tags to monitor the effectiveness of websites of other entities that provide us with recruitment or marketing services, collect statistics on website users or manage cookies.

3. The user can disable beacons by rejecting certain cookies associated with the tag. Such a tag can still record anonymous visits from the IP address of a specific user, but the information collected by cookies will not be recorded in this case.
4. Some newsletters or other messages sent by Camsat contain embedded links that allow you to confirm the email address of the recipients. We use the information collected in this way to determine your interests and improve the quality of your future user experience.

## **§ 5. Location tools**

1. Camsat may collect and use data on the geographical location of the user's computer or mobile device. Location data is collected to provide users with information about services we believe may be of interest to them because of their location. They are also collected in order to improve our products and services based on geolocation solutions.

## **§ 6. Widgets and social applications**

1. The Camsat websites may contain functions that allow you to share content using third party social applications, such as, among others, "Like" button on Facebook or a widget on Twitter, Instagram. All of these social applications can collect and use data on user activity on Camsat websites. Any personal data provided by users through such social media applications may be collected and used by other users of the above social media applications, and their interactions are subject to the privacy policy of the companies that are the application providers. We have no influence and we are not responsible for the above companies and their use of user data.
2. Additionally, Camsat websites may host blogs, message boards, crowdsourcing sites, and other applications or services (collectively, "social features"). The purpose of social functions is to facilitate the sharing of knowledge and content. Any personal data provided by users using any of Camsat's social functions may be shared with other users of a given social platform (unless otherwise stated when collecting it), over which we have limited control and we do not have it at all.

***Providing personal data on the website [www.camsat-cctv.com](http://www.camsat-cctv.com) is voluntary. The basis for data processing is my consent. I have an influence on the web browser and its settings. The recipients of personal data may be Google, Facebook, Call Page, Tawk. I have the right to withdraw my consent at any time by changing the settings in my browser. Personal data will be processed and stored depending on the period of using the technology. I have the right to request the administrator to access my personal data, rectify it, delete it or limit the processing of this data, as well as the right to lodge a complaint with the supervisory authority. Profiling is used in Google Analytics, Google AdWords, Facebook Pixel. If you object to profiling, please optimize your browser accordingly.***

## **§ 7. Cookies**

### **What are cookies**

Cookies are small files that are saved and stored on your computer, tablet or smartphone while you visit various websites on the Internet. A cookie usually contains the name of the website it comes from, the cookie's "lifetime" (that is, its lifetime), and a randomly generated unique number used to identify the browser from which the website is connected.

### **Cookie Policy.**

1. In connection with the provision of the content of the website [www.camsat-cctv.com](http://www.camsat-cctv.com), the so-called cookies, i.e. information saved by servers on the user's end device, which servers can read each time you connect to this end device, may also use other technologies with functions similar or identical to cookies. In this document, information on cookies also applies to other similar technologies used as part of our websites. Cookies are IT data, in particular text files, which are stored on the end device of the user of the website [www.camsat-cctv.com](http://www.camsat-cctv.com). Cookies usually contain the name of the website domain they come from, the storage time on the end device and a unique number.

2. Cookies are used for the following purposes:

1. adjusting the content of the website pages to the user's preferences and optimizing the use of websites; in particular, these files allow to recognize the user's device of the website and properly display the website, tailored to his individual needs,
2. creating statistics that help to understand how website users use websites, which allows improving their structure and content.

3. As part of the [www.camsat-cctv.com](http://www.camsat-cctv.com) website, we may use the following types of cookies:

1. "necessary" cookies, enabling the use of services available on the website, e.g. authentication cookies used for services that require authentication on the website,
2. cookies used to ensure security, e.g. used to detect fraud in the field of authentication within the website,
3. cookies, enabling the collection of information on the use of the website pages,
4. "functional" cookies, enabling "remembering" the settings selected by the user and personalizing the user interface, e.g. in terms of the language or region the user comes from, font size, website appearance, etc.,
5. "advertising" cookies, enabling the delivery of advertising content to users more tailored to their interests.

4. In many cases, the software used for browsing websites (web browser) allows cookies to be stored on the user's end device by default. Website users can change their cookie settings at any time. These settings can be changed in particular in such a way as to block the automatic handling of cookies in the web browser settings or inform about their every posting in the user's device of the website. Detailed information on the possibilities and methods of handling cookies is available in the software (web browser) settings. Failure to change the cookie settings means that they will be stored on the user's end device, and thus we will store information on the user's end device and access this information.

5. Disabling the use of cookies may make it difficult to use some services on our websites, in particular those requiring logging in. However, disabling the option of accepting cookies does not make it impossible to read or view the content posted on the [www.camsat-cctv.com](http://www.camsat-cctv.com) website, subject to those to which access requires logging in.

6. Cookies may be placed on the end device of the user of the website [www.camsat-cctv.com](http://www.camsat-cctv.com), and then used by advertisers cooperating with the website, research companies and suppliers of multimedia applications.
